

## Rushall Organic Farm Residential (Camping) Risk Assessment

Numeric System. Severity 1-5 & Likelihood 1-5. Multiplied to give Risk (Maximum 6).

Covers all Camping Activities but should be used in conjunction with the Risk Assessment for all sites for school visits and both the habitats and farming risk assessments for the appropriate Keystage.

**NB activities supplied by external providers have their own risk assessments as provided by the supplier e.g. Canoeing, Archery. The John Simonds Trust retains copies of these.**

**Important note: The greatest risk in visiting a farm is the transfer of disease from livestock to visitors (zoonosis). This is manageable with the correct procedures and by appropriate hand washing after contact with the animals. Hand washing facilities are available at both Rushall Farm (in the toilets and lambing shed) and at Rushall Manor Farm. Hand washing should be conducted using soap and water. The soap contains an antibacterial and is purchased from Bowak. Hand gel is not an adequate substitute. Water temperature at the hand washing facilities is checked and adjusted accordingly. It is imperative that the last thing visitors do is wash their hands. Shoe changing should be done prior to this regardless of what the coach driver would like. Boots that have been worn at the farm can be dipped in a Virkon solution. There is biosecurity. Other shoes should be bagged and cleaned at home (see below).**

All visitors are told they cannot eat whilst the visit is in progress. All schools lunch at Rushall Manor Farm. Some schools will give their students a snack before the visit commences and this is supervised by both school and trust staff.

Use of torches, going to the toilets after dark - inform someone in the tent if you are going to the toilet in the dark, if someone is taking a very long time and other children concerned see a member of staff, keeping to own tents, if someone is making a poor choice let a member of staff if they continue etc.</li> <li>5. Barbeque	Children & staff	Smoke - eyes, inhalation. Burns. Under cooked food	<ol style="list-style-type: none"> <li>1. Children have a designated area for sitting</li> <li>2. Staff only near barbeque</li> <li>3. No uncontrolled behavior</li> <li>4. Food checked that it is cooked thoroughly</li> <li>5. Moving around area where and when asked</li> <li>6. Water ready in case of a burn</li> </ol>	2	2	4
Woodland cooking. (Baked beans on mini barbeques)	Children & staff	Burns, smoldering leaves/undergrowth.	<ol style="list-style-type: none"> <li>1. Set up mini barbeques in area with no undergrowth/ leaves.</li> <li>2. Children given very clear instructions on behavior.</li> <li>3. High level of supervision approximately 1:5</li> <li>4. Adults light barbeques.</li> <li>5. Water on hand incase problems arise.</li> </ol>	2	2	4

Hot weather	Children & staff	Burning, sun stroke, dehydration, vomiting & headaches.	<ol style="list-style-type: none"> <li>1. Wear a sun hat, suitable clothing to cover up</li> <li>2. Apply sun cream regularly - awareness that wind and being outside may also need sun cream</li> <li>3. Children aware of dangers &amp; precautions</li> <li>4. Drink plenty of water / fluids to keep hydrated</li> </ol>	2	2	4
Wet weather	Children & staff	Slipping, dampness, cold.	<ol style="list-style-type: none"> <li>1. Be aware of wet slippery surfaces when walking</li> <li>2. Wear appropriate footwear</li> <li>3. Waterproof clothing &amp; hats</li> <li>4. Check tents and ensure clothes are stored securely</li> <li>5. Change out of wet clothes - dry wet clothes if possible</li> <li>6. Heavy rain - shelter inside</li> <li>7. Hot showers &amp; cold &amp; warm drinks</li> <li>8. Check to see any signs of longer term effects</li> </ol>	1	2	2
Thunder & lightning	Children & staff	Children frightened. Risk of being struck by lightning or debris falling on the children.	<ol style="list-style-type: none"> <li>1. Be aware of weather conditions each day and any approaching bad weather</li> <li>2. Brief the children on expectations - what to do and what not to do</li> <li>3. Take the children inside until the weather clears</li> <li>4. Check all the children are safe and reassure</li> </ol>	4	1	4
Preparing food	Children & staff	Cuts, splashes in eyes, food poisoning	<ol style="list-style-type: none"> <li>1. Listen &amp; follow instructions</li> <li>2. Adult supervision</li> <li>3. Not to be allowed near cookers etc.</li> <li>4. Extreme care if walking around carrying equipment</li> <li>5. Wash hands before, during and after preparation</li> <li>6. Safety procedures for knives, can openers etc.</li> </ol>	2	2	4
Cleaning up after meals	Children & staff	Bumps, burns, cuts.	<ol style="list-style-type: none"> <li>1. Awareness of water temperature</li> <li>2. Awareness of wet floors being slippery</li> <li>3. Move sensibly around when carrying items and when around others</li> <li>4. No uncontrolled behavior</li> </ol>	2	2	4
Wet floors in bathrooms	Children & staff	Slips & bumps	<ol style="list-style-type: none"> <li>1. Extreme care to be taken when floors are wet</li> <li>2. Try to avoid any unnecessary water ending up on the floor</li> <li>3. Mop up floors to remove excess water</li> <li>4. Floors are checked during times of greatest use</li> </ol>	1	2	2
